#### Information for customers on use of their data and their rights

## Dear Customer,

In accordance with Art. 13 of the General Data Protection Regulation (EU) 679/2016 (hereinafter the "Regulation"), in order to provide you with insurance products and/or services requested by or envisaged for you we need to collect and use certain data relating to you.

#### WHAT DATA DO WE COLLECT?

We collect personal data that allow us to assess the adequacy of the insurance contract that we offer you in relation to your insurance needs and your risk propensity.

Consent to the use of your personal data is thus necessary for the preparation of insurance proposals and any refusal to provide even part of the information requested could compromise our assessment of whether the contract meets your needs.

### HOW WE TREAT YOUR DATA

Your personal data will not be disclosed to others; your data will be processed by employing appropriate means and procedures, including IT and computerised systems, and may become known solely to persons duly authorised by the Company to perform the aforementioned assessment. Your personal data will be stored in full accordance with the security measures laid down by personal data protection regulations for the duration of the insurance contract and, after the expiry thereof, for the period prescribed by regulations concerning the storage of documents for administrative, accounting, tax, contractual and insurance purposes (normally 10 years).

Your personal data may also be acquired and used by other Unipol Group companies<sup>(1)</sup> and communicated to reinsurance companies, in Italy and abroad, to allow SIAT Compagnia di Assicurazioni e Riassicurazioni S.p.A. to arrange reinsurance cover and to other insurance companies for the transfer of coinsurance shares. The data may also be communicated only if required by law, or, for the purposes described above, to IT service, storage or other technical or organisational service providers.

# WHAT ARE YOUR RIGHTS?

Privacy legislation (arts. 15-22 of the Regulation) grants you the right to access your data at any time, as well as to request rectification of or additions to the data, if inexact or incomplete, erasure of the data or restriction of processing thereof, if there are valid reasons for doing so, or to object to the processing thereof for reasons attributable to your specific situation, as well as the right to data portability, where the data has been processed by an automated system for the provision of the contractual services requested by you, within the limits of the provisions of the Regulation (art. 20). The data controller responsible for processing your personal data is SIAT Compagnia di Assicurazioni e Riassicurazioni S.p.A. (<a href="www.siat-assicurazioni.it">www.siat-assicurazioni.it</a>) based at Via V Dicembre, 3 - 16121 Genova. You also have the right to revoke your consent to the use of the aforementioned remote insurance contract marketing communication techniques or, however, to object, at any time and free of charge, to this type of marketing communications (art. 15 of ISVAP Regulation 34/2010) and, in particular, to the use of automated contact systems.
